### LOANS TO GOVERNMENT

Hon. W. S. FIELDING (Minister of Finance). No money is due by the government to banks in Canada for loans or overdrafts. Our temporary loans are in the form of two issues of treasury bills which have been placed in London. One of these, for £500,-000, was placed on October 1st, 1903, at a time when the state of the market was one of exceptional stringency This loan was for six months, and the rate of interest was fixed at  $4\frac{1}{2}$  per cent. The second issue is for £800,000, and was placed January 1st, 1904, for four months. The rate of interest was 35 per cent. These loans were placed through the government's financial agents in London, the Bank of Montreal.
