ers in trouble the resources of medicine and psychiatry. It must ensure a greater understanding of unwed mothers and of their children and actually meet their needs. It must promote research and the implementation of a more adequate social and family policy.

Everybody seems to agree on the meaning of the word life. But we are unable to define health, because this term is quite ambiguous. It is all very well for the legislature to use it, but somebody else will have to interpret it. Numerous pieces of legislation give rise to the same problem. I think the world life is clearly defined. We all know what we are talking about and we can actually tell if the life of such or such a woman is in danger.

Mr. Speaker, it is wise for the legislation to require that three doctors sign the certificate, and such is the main purpose of this motion. Doctors will enjoy some protection, patients will be assured that their case will receive serious consideration and will not be treated as mere correspondence.

Doctors who have authorized therapeutic abortions are certainly no criminals.

I feel this motion will clarify the legislation under consideration and that it will be approved by the house.

Mr. Jean-Charles Cantin (Parliamentary Secretary to the Minister of Justice): Mr. Speaker, the comments which we could have made on that amendement were similar to those made when amendment No. 35 was under consideration. I had the opportunity yesterday to say a word on that amendment and the same remarks apply, but I would add that this afternoon, the Minister of Justice (Mr. Turner) set forth the reasons why he rejected amendment No. 38.

Now, amendment No. 37 has the same meaning and the same motivation as amendments Nos. 35 and 38. Then, the same arguments apply and for the same reasons, the government cannot approve that new amendment.

Mr. Pierre De Bané (Matane): Mr. Speaker, as mentioned by the hon. member for Louis-Hébert (Mr. Cantin), the amendment now under consideration moved by the hon. member for Beauce (Mr. Rodrigue) is a rehash of the one discussed yesterday.

Through a legal expedient, the Ralliement créditiste has decided to destroy the democratic mechanism which is Parliament.
