PUBLIC SERVICE-EMPLOYMENT OF MR. ROD BRYDEN

Question No. 1,275-Mr. Burton:

1. Has Mr. Rod Bryden been employed in the office of the Minister of Manpower and Immigration at any time since July 1, 1968 and, if so (a) when did he commence employment (b) when was this employment terminated (c) what post did he hold (d) what was his salary (e) what advisory group, special

SUBSIDIZED AIR SERVICE TO THE FAR NORTH

Question No. 1,301-Mr. Yewchuk:

Does the government intend to set up a subsidized air service to the far North for passenger and transport purposes?

Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): No, the government has no plans at this time to establish subsidized air services in the North. The Department of Transport and the Department of Indian Affairs and Northern Development spend considerable sums annually on the construction and maintenance of aviation facilities in the North. The Department of Transport is currently undertaking a major study of air facilities and services in the Arctic to determine when and where improvements should be effected.
