Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): I believe we have one, Mr. Speaker, but it would not be terribly wise to announce it today.

### SURVEY OF INVESTMENT INTENTIONS IN CONSTRUCTION MACHINERY—REQUEST FOR MEASURES TO STIMULATE INVESTMENT AND ENCOURAGE EMPLOYMENT

Hon. Robert L. Stanfield (Leader of the Opposition): I should like to ask the Minister of Industry, Trade and Commerce a question arising from the survey of investment intentions conducted by his department which shows an intention to increase investment in construction, machinery and equipment by a mere 3 per cent in 1972 as opposed to 10 per cent this year. Could the minister tell the House whether his department or the government proposes to adopt any measures to stimulate investment which will encourage employment?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): The statement is more intelligent than the use that is made of it, Mr. Speaker, because it points out a number of factors that are changing now. Among those is the announcement recently made by the Minister of Finance of cuts in taxation for corporations and individuals.

## ALLEGED PROPOSAL BY UNITED STATES TO CONTINUE EMBARGO ON ENRICHED URANIUM FROM CANADA

**Mr. Maurice Foster (Algoma):** I have a question for the Minister of Industry, Trade and Commerce. In view of the recently announced policy proposal of the United States Atomic Energy Commission to continue the embargo on enriched Canadian uranium for the United States market to the late 1970's from the previously announced date of July, 1973, does the Canadian government intend to for-
