# CALL FOR AMENDMENT OF RESOLUTION—MOTION UNDER S.O. 43

#### GOLDFARB CONSULTANTS—CALL FOR INJUNCTION AGAINST PUBLICATION OF 1981 REPORT—MOTION UNDER S.O. 43

Whereas the October 11 edition of the *Financial Post* carries an advertisement by Goldfarb Consultants soliciting subscriptions to its 1981 report which would include: "A detailed treatment of public attitudes towards the debate surrounding a new constitution;" and whereas that information appears to come from the polls which the Canadian Unity Information Office asked Goldfarb to conduct and which the Minister of Justice (Mr. Chrétien) yesterday refused to disclose because, as he said, "disclosure could be injurious to the conduct of federal-provincial affairs", I move, seconded by the hon. member for St. John's East (Mr. McGrath):

That the government be instructed to seek an injunction against the publication or distribution of the 1981 Goldfarb report, and that the Minister of Justice be instructed to take the necessary steps to prevent such private and mercenary misuse of information paid for by all Canadians.
