## GARRISON DIVERSION

UNITED STATES FUNDING OF PROJECT

Mr. Roland de Corneille (Eglinton-Lawrence): Madam Speaker, my question is directed to the Secretary of State for External Affairs. A week ago last Thursday the U.S. Senate appropriations committee approved additional funding of \$4 million for work on the Garrison diversion project. This comes after a statement by the United States Interior Secretary that he is fully behind the Garrison project. Can the minister assure the House that the Government of Canada will seek guarantees that the additional funding will not be spent on parts of the project which could harm Manitoba waters, or that it does not represent a commitment of any kind toward the completion of the entire project?

Hon. Mark MacGuigan (Secretary of State for External Affairs): Madam Speaker, I thank the hon. member for raising this important question again. It is one that greatly concerns the government and is one which I have frequently discussed with my colleague, the Minister of Employment and Immigration.

The alleged comment of the U.S. Secretary was referred to previously in this House. We have been informed by his office that he did not make any such comment during his visit to the contiguous part of the United States but that a rather careless newspaper headline, which was not reflected in the story, probably gave rise to that impression. We are, of course, concerned about the action of the U.S. Senate committee. We have made representation to them before and we have since discussed the matter with the U.S. government.

The relieving factors at the present time are, first of all, that it is still a decision of the committee and not of the whole Senate and, second, there are some legal problems with it which may mean that, in any event, it may not be appropriate to be attached to an appropriate bill.

Beyond that, there is written into the legislation, at the stage at which it is now, the instruction that it must not be used for any construction which would in any way affect Canada. Of course that is the assurance we are seeking. It is the assurance which the U.S. administration repeated to us as recently as last week.

APPEARANCE OF CANADIAN PIPERS AT EDINBURGH INTERNATIONAL TATTOO
