F-18A FIGHTER AIRCRAFT CONTRACT—INQUIRY WHETHER NOTICE OF DELAY RECEIVED

Hon. Allan B. McKinnon (Victoria): Madam Speaker, my question is directed to the Minister of Supply and Services. Under the rather feckless new fighter aircraft contract, McDonnell-Douglas cannot be held responsible for "excusable delays", a very broad category which includes "any action of government". As the United States government has delayed the defence systems acquisition review council decision on F-18A production, and as the Australian government has postponed its decision on a possible F-18A purchase, has our government received any notice of delay as required by the contract?

Hon. J.-J. Blais (Minister of Supply and Services): Madam Speaker, we have not received any notice of delay under the contract.

Mr. McKinnon: Madam Speaker, my supplementary question is directed to the same minister. In the new fighter aircraft contract, the October 31 payment, milestone No. 5, brings the cumulative total payment to \$25 million; but that payment was subject to "completion of a review of contractor progress by the contract authority", that is, the government. Was the review made, was it satisfactory, and was the payment made?

Mr. Blais: Madam Speaker, with reference to that specific contract, I will have to inquire and inform the hon. member.

SUGGESTED INVESTIGATION OF SITUATION IN POLAND BY SECURITY COUNCIL

Mr. Jesse P. Flis (Parkdale-High Park): Madam Speaker, my question is supplementary to the one posed by the Right Hon. Leader of the Opposition. Since he has difficulty posing questions on Poland, I thought I would ask this question of the Prime Minister.

Mr. Flis: In view of the fact that the Soviet Union has apparently completed its preparations for a possible intervention in Poland, and that the United Nations, under Chapter VI, article 34 of its charter, may have its security council investigate any dispute or any situation which might lead to international friction or give rise to a dispute in order to determine whether the continuance of the dispute or situation is likely to endanger the maintenance of international peace and security, would the Prime Minister say whether he is prepared to ask the United Nations Security Council, through proper channels, to proceed under the terms of article 34 in an effort to maintain world peace?

Right Hon. P. E. Trudeau (Prime Minister): Madam Speaker, certainly I think that is a most worthy suggestion and I will bring it to the attention of the Secretary of State for External Affairs.
