CANADA POST CORPORATION

CONSULTATION WITH COMMUNITIES

Mr. Albert Girard (Restigouche): Mr. Speaker, my question is for the Minister responsible for Canada Post Corporation. Recently, the Standing Committee on Government Operations presented its second report to the House. The report stressed the importance of consultation. During hearings the committee was presented with horrendous stories concerning the lack of consultation between Canada Post and the population it is supposed to serve. Will the Minister instruct Canada Post to confirm its commitment to service by undertaking meaningful consultation with all communities affected by its decisions?

Hon. Harvie Andre (Minister of Consumer and Corporate Affairs): Absolutely, Mr. Speaker. There certainly were mistakes made in the past. But, as I have indicated to the House, the consultations are to be meaningful and to involve the Member of Parliament from the start. As an example, in the town of St. Albert in the constituency of Glengarry—Prescott—Russell the Member for that riding was actively involved in discussions, as there was a change in the postal services there. I understand from the Hon. Member, from Post Office officials and others, that it went very well and everybody was involved. The consultations were meaningful and to everyone's satisfaction.

I hope that that will be the pattern for the future. I hope that Members of Parliament will keep me apprised if in fact we slip off that pattern since we all have a responsibility in this regard.

Hon. Harvie Andre (Minister of Consumer and Corporate Affairs): Mr. Speaker, I think I remember the question, but first let me congratulate the Hon. Member for Hamilton East on this tremendous occasion.

The Hon. Member for Winnipeg North Centre is aware that all 28 contracts which various bargaining units have with the Post Office are up. They are under active negotiation. They are at the table now. It is in his interest, in our interest, and in everybody's interest that we try not to involve ourselves in those issues and thereby inadvertently provoke some action which could only be damaging to the collective bargaining process and to Canada.
