AIRPORTS

SAFETY FACILITIES AT VICTORIA INTERNATIONAL

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, my question is directed to the Minister of Transport: it concerns air traffic safety.

I wonder if the minister is aware that the lives of Air Canada passengers were endangered at Victoria international airport recently when on the night of December 15-16 last a scheduled Air Canada flight landed late at that airport without the protection of the fire engine crash crew because the fire hall had not been notified of a delayed flight, as was the course of action that had been agreed upon many weeks before, and that a similar incident occurred earlier in the month, on December 2?

Hon. Otto E. Lang (Minister of Transport): No, Mr. Speaker.

Mr. Munro (Esquimalt-Saanich): Since the minister was not aware of that, he is now aware of it. Is the minister aware that there is a possibility that aircraft could still land there without the protection of the fire engine and crash service? What are his officials doing to ensure that safety is assured there as it is elsewhere?

Mr. Lang: Mr. Speaker, obviously, any matter such as this brought to the attention of my officials is reacted to by them with the necessary steps taken. I imagine this is the reason for the hon. member's question, that there was some dissatisfaction on the part of the people involved in firefighting at that particular airport because of the amount of overtime being worked. Hence, they are coming to the hon. member with a question which I would imagine was handled in a regular way. I will look into that matter, however, and make sure I am right in saying that there is no problem for the hon. member to be concerned about.
