levied upon the whole rateable property in the suid United Counties, for the present year, the sum of \$22,000, to defray the ordinary and current expenses thereof, and the further sum of \$5,642 to pay the salaries of legally qualified public school teachers, and the further sum of \$3,326,18 as a special rate anthorized to be raised, levied and collected upon the said property in the said United Counties, under the provisions of By-law No. 310, passed on the twenty-fifth day of February, A. D. 1868, and initial "By-law to contract a loan of money by the issue of debentures for the purpose therein mentioned," and that the said several sums of money shall be apportioned to the several municipalities of the said United Counties in the following manuer, viz.:—
