Auto Law Amendments.
Lenox Amendment is Not Endorsed by Special Committee.
The special committee appointed to consider automobile legislation met yesterday and prepared a report. These are the main features of the report: The license shall be placed on the front and back of the machine. The license fee is to be increased from \$2 to \$3 and \$4 for machines over ten horse power. The owner shall be made responsible for violations of the act, whether he is driving or not, and the burden of proof of negligence shall fall on the driver. The speed limit will not be changed. Copies of the regulations, subject to certain conditions, shall be sent to the township clerk, and the township clerk shall be responsible for the enforcement of the act. The idea of compelling auto drivers to stop for a moment at the intersection of a street with the driver of the latter signals to go ahead, will be considered later.
