LOCAL MARKET.

LONDON, June 14.
The cheery countenance of Mr. Maker, the market clerk, just back from his holidays, shows that the market, though small, was brisk. New hay was a strong feature of the day. Nearly a dozen loads were drawn in, which sold rapidly from \$9 to \$9 25 per ton. Oats brought from \$1 50 to \$1 58. Most sales were made at \$1 55.

Butter and eggs were fairly plentiful, most of the eggs going at 18c, although some brought 19c per dozen. Butter, in crocks, was sold for 21c, while in rolls it brought 23c.

For vegetables and smaller fruit the market was good. New potatoes brought \$1 50 a bushel, onions, beets and new carrots were all selling at 20c. Some few dozen lettuce sold for 15c per dozen.

In fruit, raspberries brought 11c to 12c per box. Some red currants were selling at 7c, while black currants brought 15c a box. Gooseberries were on hand at 10c. There was a good supply of red cherries at 10c per box. No black cherries were offered.
