S. of Joseph LeBlanc, farmer there, by his wife, Victorie B. Girouard. B. at Memramcook, 27 Nov., 1830. Is self-educated. M., 17 Nov., 1854, Olive J. Cormier, of Buctouche, N.B., of Acadian descent. Is a farmer. Was returned to Ho. of Assem. at g.e. 1882. A protest being entered, he resigned his seat, and was re-elected Sept. 1882, and sat until Feb. 1891, when he resigned and was an unsuccessful candidate at the g.e. 5 Mar. 1891 for the Commons. Apptd to Leg. Co. 11 Mar. 1891. Was a mem. of the Executive Council from 1889 to 1891. A Liberal.—*St. Mary's N. B.*

McLELLAN, Hon. DAVID.

Father was a ship-builder from Dunfries, Scot. B. in Portland, N.B., 20 Jan., 1839. Ed. in St. John. M. in Dec., 1865, Fannie B., dau. of Henry Richards, of St. John. Is a mem. of the firm of McLellan & Hally, dealers in lumber. Was a mem. of the Ex. Council and Provl. Secty. from 28 July, 1883, to 3 Feb., 1890. Sat in House of Assem. from g.e. 1878 to g.e. 1890, when he was an unsuccessful candidate. Apptd. to Leg. Council 12 March, 1890. Re-appointed to Ex. Council, Presdt. of Council and Mem. of Board of Public Works, 20 May, 1890. A Liberal.—*Portland, N.B.*
