ELECTIONS, CONTROVERTED—*Continued.*

Recognizance on the Rouville Election Petition had been mislaid, and he had given leave to file new objections, 161.

12. Two of the Members appointed on an Election Committee having failed to attend in the House for the purpose of being sworn, they are summoned to appear at the Bar, 317. Petition referred back, and a new committee appointed, 327.

13. Certain Members exempted from serving on Election Committees, on the plea of advanced age, 53, 60.

14. A Member discharged from further attendance on a Committee, on account of illness, 325.

15. House adjourns for a short time, to enable an Election Committee to meet, 126, 396.

16. Election Committees report absence of Members; Proceedings thereon, 279, 322, 338.—Report the withdrawal of a Member, 212. He attends, and explains to the House his reasons for withdrawing; He is excused, but the House decides that the question raised by his explanations is not cognizable by the House, 213, 218.
