1st Charge : WHEN ON ACTIVE SERVICE DESERTING HIS
 MAJESTY'S SERVICE in that he at Camp Ipperwash,
 Ont., at 0700 hrs. on the 25th day of Dec. 44, absented him-
 self without leave from A.29 C.I.C.T.C., C.A. until apprehend-
 ed by M.P. dressed in civilian clothes, at Windsor, Ont., at
 1045 hrs. on the 9th day of March 1945.

2nd Charge: WHEN ON ACTIVE SERVICE DESERTING HIS MAJESTY'S
 SERVICE in that he at Windsor, Ont., when under close arrest
 did absent himself without leave from A.29 C.I.C.T.C., C.A.,
 at 0840 hrs. on the 10th day of March 1945, until apprehended
 by Civil Authorities dressed in civilian clothes at 1445 hrs.
 on the 23rd day of Aug 45 at Windsor, Ont., the cost of apprehen-
 sion and return to his corps being \$12.22.

3rd Charge : LOSING BY NEGLECT HIS CLOTHING EQUIPMENT AND
 REGIMENTAL NECESSARIES, in that he at Camp Ipperwash, Ont.,
 on the 10th day of Sep 45, was deficient in his kit articles
 valued at \$30.33.

and the Court find him guilty of the first and third charges
 and not guilty of the second charge.

and sentence him..... be imprisoned with hard labour for a period
 of six months and to be placed under stoppages of pay until....
 he has made good the sum of \$30.33 in respect of the cost
 of articles of clothing, equipment and regimental necessities....
 as set out in the charge, lost by neglect and to be discharged
 with ignominy.
