## NATIONAL DEFENCE

STATEMENT ON SHOOTING OF CANADIAN SEAMAN AT HAWAII

On the orders of the day:

Mr. Paul Hellyer (Parliamentary Assistant to the Minister of National Defence): On July 24, Mr. Speaker, the hon. member for Comox-Alberni asked a question concerning a shooting incident which occurred recently in Hawaii. The commanding officer of H.M.C.S. Crescent reports that able seaman I. W. Thompson was shot and seriously injured by a United States marine corps private in civilian clothes, who was attempting to rob him during a car ride that this Canadian seaman had accepted from Honolulu to Pearl Harbor.

The bullet lodged close to Thompson's spine, resulting in partial paralysis of the lower limbs; but medical authorities at Tripler hospital, where he is under treatment, consider this a temporary condition and there is every hope that he will make a complete recovery. Criminal charges are being prepared against his assailant by the United States police authorities in Honolulu. I might add that seaman Thompson's interests are being looked after by the British consul in Hawaii.

WINNIPEG—ALLEGED LOW FLYING OF R.C.A.F. PLANES

## POWER

PASSAMAQUODDY PROJECT—STATEMENT ON PROGRESS OF DEVELOPMENT SURVEY

On the orders of the day:

Hon. L. B. Pearson (Secretary of State for External Affairs): Yesterday the hon. member for Charlotte asked me, as he has asked me previously, whether I could report on the proposed reference to the international joint commission concerning the Passamaquoddy tidal power project. I can now announce, Mr. Speaker, that the governments of Canada and the United States have agreed upon the text of a joint reference to the commission on this subject. The reference was delivered to the commission this morning in Ottawa.

Hon. members will recall that in 1948 a joint reference was submitted to the commission by Canada and the United States for the purpose of carrying out a preliminary investigation to ascertain the scope and probable cost of a full scale investigation of the Passamaquoddy tidal power project. Based upon the report submitted by the commission in 1950, the governments of Canada and the United States have agreed, as previously announced in this house, to submit a reference on this matter. The terms of that reference are being made public this morning in Washington and in Ottawa.
