ATHOLVILLE, N.B.—INVITATIONS TO INAUGURATION OF NEW PROJECT

On the orders of the day:

Hon. Lionel Chevrier (Laurier): I should like to direct a question to the Minister of Defence Production. Has the minister sent out invitations to the inauguration of a new defence industry at Atholville, New Brunswick, which is to take place tomorrow?

Hon. Raymond O'Hurley (Minister of Defence Production): Mr. Speaker, there is a ceremony tomorrow involving the blessing of the building or the inauguration of the project. I have had absolutely nothing to do with the sending out of invitations, and the only knowledge I have is that I will be taking part.

Mr. Chevrier: Is the minister aware that invitations to the official opening have been sent out in his name?

Mr. O'Hurley: I am not aware that they are in my name. I know I will be attending, but I was not aware of invitations being sent out in my name.

Hon. J. W. Pickersgill (Bonavista-Twillingate): I should like to ask a supplementary question. Is the minister aware that on May 12 there was a ceremony involving turning the sod on provincial land for the building which is being constructed by the provincial government to house this industry, and can the minister say why he was not there?

Mr. O'Hurley: I hope the hon, member for Bonavista-Twillingate does not mean to imply that I sent out those invitations also.

Mr. Pickersgill: No. I thought the minister would have liked to be there with the premier of New Brunswick.

Mr. Speaker: Order. I think the urgency of that meeting is in the past.
