1. How many persons with less than 20 years' regular and wartime service have been released with pension from each of the armed services during each of the years since 1955?
2. Were any of these persons released because of inefficiency or misconduct and, if so, how many in each year, in each service, and for what reason?
3. How many persons with over 20 years' regular and wartime service have been honourably released from each of the armed services without entitlement to a pension since 1955?
