Inquiries of the Ministry

Depending upon circumstances and the manpower available to do the necessary work on the return, replies from various units arrived back at headquarters over a period of time.

In so far as the specific item mentioned by the hon. member is concerned, this was reported from Quebec command at the beginning of March. At that time, although detailed reports had been made to the police on the important military equipment stolen from Shawinigan armoury, stocktaking of individual items of clothing had not been done. However, stocktaking was carried out on March 16 and as a result of the hon. member's complaint I have now obtained a list of clothing stolen at that time. This list includes: 13 blue berets, 16 ponchos, 1 groundsheet, 10 khaki shirts, 5 battledress trousers, 14 olive drab field service trousers, 33 pairs of high black shoes, 16 trouser belts, 86 pairs of gloves, 22 neckties, 4 pairs of mittens and 137 pairs of socks. I might say, Mr. Speaker, that much of this has now been recovered by the police, but again at this date a detailed list is not available.

should like to draw attention to the fact that questions of this nature require a considerable amount of work and result in substantial cost to the public. I put a written question on the order paper, and the ridiculous answer was given that an unknown quantity of military clothing was stolen. Now the minister is attempting to explain away the inefficiency within his department. Shawinigan armouries was apparently completely stripped of military equipment and the minister was unable to

us that in March he had this information, yet my written question was answered only on Wednesday, and answered incompletely.

These lectures from ministers of the crown as to how we conduct ourselves in this house are out of place. We are entitled to ask for information from the government and we are entitled to complete answers, which we have not been getting.

We did everything we could to obtain the information for the hon. member as I have mentioned, and I think his intervention this morning is completely ridiculous.
