NEWFOUNDLAND REFINING CO. LTD. TAX EXEMPTIONS

Hon. Herb Gray (Minister without Portfolio): Mr. Speaker, Order in Council P.C. 1969-1643 amended section 1100 and Schedule B of the Income Tax Regulations to the effect that all corporations which were affected by Section 14(1) of Chapter 44 of the Statutes of 1968-69 were granted the right to accelerated capital cost allowance in respect of certain depreciable property. The Order in Council did not name any specific corporation.
