## SALE OF LAKE ERIE FRESH PERCH FILLETS

**Mr. William Knowles (Norfolk-Haldimand):** My question is directed to the Minister of Fisheries and Forestry. In view of the fact that his department and the provincial government have declared Lake Erie fish to be free from pollutants, and as the minister has also ascertained this from first-hand inspection, would he issue a directive to his inspectors to permit the sale of fresh fillets of perch which is a very lucrative market for the fishermen who sell this product?

**Hon. Jack Davis (Minister of Fisheries and Forestry):** The question is one of testing all of the fish. At present the fish have to be held for some time and therefore have to be held in frozen form. Until we have sufficient testing apparatus and men trained to speed up the tests in large numbers we are unable to clear the fish. We want to be absolutely sure that the fish meet all our requirements before they are sold in this country or exported.

**Mr. Knowles (Norfolk-Haldimand):** Would the minister at least undertake to speed up the testing process? These men are forced to hold them for periods of up to two weeks before they can get an answer.

**Mr. Davis:** We have several new machines on order and we are training the necessary staff as quickly as we can.

**Hon. Jack Davis (Minister of Fisheries and Forestry):** We know that the source of the mercury pollution is the FMC Chemicals caustic soda and chlorine plant at the head of Howe Sound. We do not know the extent of the pollution, but we hope to have the results on fish tests by the end of the week.

CHEDABUCTO BAY—PAYMENT OF

**Mr. J. M. **Hon. Donald C. Jamieson (Minister of Transport):** The procedure has been explained to the residents of Chedabucto Bay on a number of occasions by both representatives of my department and the Department of Fisheries and Forestry. In addition, quite a job has been done cleaning up the fishermen's nets and the like, and I understand that tenders were called yesterday for the cleaning up of shore installations. So to this extent the work is under way. If there is any specific inquiry, either I or the Minister of Fisheries and Forestry will be glad to look into it.
