**Mr. Lalonde:** Mr. Speaker, I cannot give a firm date to the hon. member but I can tell him that the health protection branch of my department has not yet received sufficient evidence from properly constituted and controlled clinical investigations which would substantiate any conclusions for the efficacy of high doses of vitamins in the treatment of psychiatric conditions or the common cold.

### HUMAN RIGHTS

REASON FOR DELAY IN PROCEEDING WITH SECOND READING OF BILL—POSSIBLE INCLUSION OF PROVISION COVERING HATE MESSAGES BY TELEPHONE

**Mr. Lincoln M. Alexander (Hamilton West):** Mr. Speaker, I have a question for the Minister of Justice. Now that Bill C-72 has been mentioned by the Minister of Finance in dealing with the federal human rights legislation and seeing that the minister has now met with his provincial counterparts regarding this very important matter, can he give us any reasons why he cannot proceed with the early introduction of this bill for second reading after the Christmas recess?

**Hon. Ron Basford (Minister of Justice):** Mr. Speaker, we had a very useful meeting, and as a result of that discussion, I shall be making some recommendations to my colleagues in cabinet with regard to the bill. I would hope it could be proceeded with in the session following Christmas.

**Mr. Alexander:** A supplementary question, Mr. Speaker. Another matter of some sensitivity involves Bell Canada and hate messages. Has the minister directed his attention to this particular matter and was it discussed with his provincial counterpart? Is he going to move in this particular area to outlaw these messages and will there be room for censorship by Bell Canada? Is this the type of thing he is recommending to his colleagues to be brought within the human rights legislation or will there be separate legislation?

**Mr. Basford:** Mr. Speaker, it was raised by the delegation from Ontario and I have also had correspondence and discussion on the subject with my counterpart, Mr. McMurtry. I am not proposing that we should introduce in that bill, or any other, some form of censorship, but I am conscious of the problem and issue raised by the government of Ontario and have undertaken to examine both their specific proposal and other proposals, to see if the problem can be dealt with either under the Human Rights Act or some other appropriate piece of legislation. That is one matter on which I am reflecting following our meet-
