picking of Air Canada, because I do not agree with those arguments being put forward. I think we make a good case in relation to our long-term, long-standing position at Heathrow, having regard to the fact that three American airlines which are also there are not being asked to move. Therefore, we resist the United Kingdom's argument about convenience of traffic diversion. I would say that I do not see a direct connection between that issue and the issue of access by British Airways to western Canada.

SALES TAX REBATE ON INVENTORIES OF MANUFACTURED GOODS

Mr. A. D. Alkenbrack (Frontenac-Lennox and Addington): Mr. Speaker, my question is for the Minister of Revenue and Minister of State (Small Business): it concerns the recent reduction of 3 per cent in the federal sales tax on manufactured goods. This question was raised today by the hon. member for York-Simcoe and in the way of a Standing Order 43 motion by the hon. member for Red Deer.

Considering the certainty of great financial loss to certain businesses such as automobile and machinery dealers who have substantial inventories on which the old 12 per cent sales tax

has been paid, will the minister indicate whether he is considering some form of adjustment in the sales tax formula that would minimize the financial loss of those businesses?

Hon. A. C. Abbott (Minister of National Revenue and Minister of State (Small Business)): Mr. Speaker, in my previous answer I indicated that very real difficulties are present because of the enormous number of products that have been manufactured, sold and stored in inventory. It is very hard to draw the line. In the past there were some remissions granted in cases where the tax had been specifically reduced; for example, on automobiles and trucks.

What I did not say in my answer last time to the question, which probably I should have said, is that because this matter is a part of the budget and, therefore, within the formulation of taxation, the question should more properly have been addressed to the Minister of Finance. Nonetheless, I would reiterate the points I made, that very considerable difficulties are present in attempting to grant remissions in respect of so many millions of transactions which involve many thousands and millions of dollars in inventories that have been stored over such a long period of time.
