Miss Carney: —than what it paid for the crude oil.

## ATLANTIC GROUNDFISH QUOTA ALLOCATIONS

Mr. Gerald Comeau (South West Nova): Mr. Speaker, my question is directed to the Minister of Fisheries and Oceans. In a letter dated December 17, 1985, I asked the Minister to review the Atlantic groundfish quota split between the inshore and offshore fishing industries. As thousands of jobs in my riding are dependent upon the fair allocation of this stock, and the successful resolution of this matter is of primary concern to my constitutency, will the Minister advise the House with respect to any progress on my request?

Hon. Thomas Siddon (Minister of Fisheries and Oceans): Mr. Speaker, I very much appreciate the representations made by the Hon. Member, beginning with his letter of December 17. When I met with my Atlantic colleagues, the Atlantic Council of Provincial Fisheries Ministers, on December 11, we decided jointly on a proposal with respect to the split of allocations between the inshore and offshore sector of southwest Nova Scotia. That proposal was supported by the Minister of Fisheries for Nova Scotia. With my colleague from Nova Scotia I am now examining the possibilities of amending the distribution of these stocks. I would point out that, in fact, the landings last year were at unprecedented levels in Southwest Nova. I think, as in all other respects, there even appear to be more fish in the sea under a Tory Government.
