In spite of what the Hon. Member is trying to get at with the question, let me state one overriding consideration that his Leader will support. DEPARTMENT'S STATISTICAL INFORMATION

Mr. Ian Deans (Hamilton Mountain): Mr. Speaker, I have a supplementary question for the Minister of Finance. Now that Informetrica has confirmed what my Leader said over a week ago, that there would be a net loss of 50,000 jobs to the economy as a result of the Government's economic statement, is the Minister now willing to provide for the House of Commons and for the public of Canada the statistical information that was made available to him by his ministry officials, and show conclusively exactly how many jobs his Government is prepared to risk in an effort to achieve the kind of economic Utopia that it claims might occur some time in the future?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, we are not trying to achieve an economic Utopia. We are trying to withdraw ourselves out of a very serious problem that we are facing as a country and as a Government. We are taking the steps that we feel are necessary. The Hon. Member has seen the results of the Informetrica modal. I am sure there will be others that will be somewhat less. There may be others that are somewhat more. I say to the Hon. Member that he must look at the broader reasons for the action that we took last Thursday.

REQUEST FOR RELEASE OF INFORMATION

Mr. Ian Deans (Hamilton Mountain): Mr. Speaker, my supplementary is a very simple question. It surely can be answered. The Minister has in his possession statistical information given to him by his ministry officials which shows that there will be a loss of jobs as a result of the economic direction the Government has decided to take. Will the Minister provide for the House the information that was given to him, in order that the public of Canada can draw some reasonable conclusions as to whether or not those are the risks that they are prepared to take in order to achieve the aims that the Government wants to achieve?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, I have said in the past, and I will say it again to the Hon. Member, that this information was provided to me as part of an over-all policy recommendation. I do not believe that it is

appropriate for Ministers of the Crown to be making information available publicly to Members in the House and the general public which is part of a set of policy options. That is the reason for my not making that information available.
