

**FATAL STRIKE RIOTS AT BUCKINGHAM, P. Q.;
TWO DEAD; SEVERAL MORTALLY INJURED****Detectives Fire Point Blank Into Charging Mob Killing Two of the Leaders—
Militia With Machine Guns Rushed from the Capital.**

Buckingham, Que., Oct. 8.—A terrible affray took place this afternoon between 200 former employees of the James MacLaren Company's mill and 22 policemen, who were guarding a band of 17 strikebreakers. Two strikers were shot dead and several severely wounded during the fighting, and the police were finally driven from their posts.

The dead are Thomas Belanger and Xavier Theriault. Belanger was the leader of the strikers and the president of the union formed a month ago to fight the company. He belonged formerly to St. Jerome, and was married only three months ago. He was about 30 years old.

Theriault had lived many years in Buckingham, and leaves a widow and eight children.

The injured strikers Felix Paquette, shot through the abdomen, and not expected to recover; Baptiste Clenow, shot in the arm and head; Felix LaCelle, shot in arm; Adelard Hamelin, four shots in arm; Edward Miner, shot in leg; Xavier Tremblay, shot in arm and leg; Isidore Renaud, shot in back; Louis Gervais, shot in wrist.

How Trouble Started.
Herbert Verrier, Montreal, of the police contingent, was shot. It is feared fatally. Other policemen badly wounded are the chief of the Buckingham force, Frank Kiernan, his brother James, Peter Pecard, Detective Leyotte and some others.

The labor trouble began a month ago, when 500 men asked for an increase of 25 cents a day. Most of them had been receiving \$1.25. The MacLaren Company, which is one of the biggest lumber concerns in Canada, responded by closing the mills, and saying that because of the low water and the consequent high price of operation a cessation of work was not in the cards. Business was suspended for a month, and during that time 300 of the strikers drifted away to the shanties, and the balance remained as a solid guard to keep the mill from working. Joe Bernardin's house was rented as headquarters, and the men watched the MacLaren property. The scene of the strike was a scene of lawlessness. The company would make no concession, and reconciliation became more remote as the time went on.

This morning it was rumored that John Vallée, the firm's manager, had brought strike-breakers into the town, and the men became more vigilant. They saw the newcomers about 7 o'clock, and at once called a meeting of the union. It was decided to stop operations at all hazards. Belanger, the leader, went home and bade his wife a pathetic good-bye, saying he might not return again. She begged him not to risk his life, but he answered that justice was on the side of the men.

Police Were Overpowered.
At 1 o'clock the strikers, some armed with rifles, marched four deep along the shore, so as not to be on the MacLaren property. The seven men were bringing logs down the St. Lawrence River. The strikers sent spokesmen to propose to the MacLarens that the strike-breakers should leave. The police answered that peace would have to be observed, and said no threats would be heeded. The messengers returned, and as soon as they joined the main body the firing began. No riot act was read. Both sides deny firing the first shot, and each claims that it fought in self-defense. Albert MacLaren and his brother Alexander faced the invaders with revolvers, and helped the police until the numbers of the union men overpowered them. The scene of the conflict was at the end of Buckingham's main street and three-quarters of a mile from the mill.

Shot Through Heart.
Belanger was well in the lead of his men, and an easy mark for the bullets. Those who were near him say he received a bullet in the heart.

**NEWFOUNDLAND IN TOWERING RAGE;
CLAIM LIBERTIES ARE CRUSHED****Dissatisfaction Over the Fishery
Modus Vivendi Rapidly
Growing.**

St. John's, Nfld., Oct. 9.—Popular anger against the modus vivendi arranged by the United States and British Governments relating to the Newfoundland herring fisheries is growing. There is a general feeling that the compromise arrived at was a backdown on the part of the British ministry.

Archbishop Howley, the Roman Catholic primate, speaking yesterday at a parish festival, declared the modus vivendi a shameful betrayal of the colonies' interests, and advocated agitation throughout the colony against it. He urged an immediate calling of the Legislature, spirited protests to the throne, the dispatch of delegates to England and to Canada, and an appeal to all autonomous British colonies to join in resisting what he termed "an unbridled invasion of colonial rights."

**Big Gale and Tornado
Hits Lake and Country****Devastation in Wake of Mid-
night Storm—Ships in
Stiff Battle.**

Ayr, Oct. 9.—A tornado struck this town about 12:30 a.m., sweeping everything in its path. Lovely shade trees by the score were snapped clean off, brick chimneys were toppled over, roofs were deprived of shingles, and electric and other wires badly tangled. The mills west of the town at Nithvale, were partly unroofed, the roofs being carried about a hundred feet away. The track of the storm was of short width, striking the town at the southwest and running in a northeasterly direction. Though its duration was short, the

**FALLING WALL
CRUSHED TROLLEY****Three Passengers Severely In-
jured in Bad Accident
at the Capital.**

Ottawa, Oct. 9.—The front wall of the Gilmour Hotel, which was recently destroyed by fire, fell on a passing street car this morning, and completely demolished it. There were only three passengers in the car and they are badly injured. How they escaped with their lives cannot be explained, because the car was smashed to pieces.

The motorman had his legs broken, and the conductor was also injured. The street was blocked for about three hours.

Those who were injured were: Alexander Potvin, foreman of the hook and ladder company, No. 8, who lives at 758 Gladstone avenue; two bones in his neck were broken, and he received internal injuries. The last rites of the church have been administered and he is not expected to live. William Campbell, contractor, Hintonburg, was badly injured. He is supposed to have fractured his skull. Miss Nellie Thompson, of 57 Munro street, is supposed to have an arm broken.

GRAIN BLOCKADE GROWS**Sidings Jammed With Loaded Cars
From Winnipeg To Lake Superior.**

Fort William, Ont., Oct. 9.—Various congestions of wheat-laden cars on the C. P. R. between Winnipeg and Lake Superior now amount to a grain blockade. Sidings everywhere are filled with loaded cars, which the company is unable to move. Only about 150 cars per day are arriving here, compared with 300 daily in the corresponding time last year. Conservative estimates are that one-third less grain will be sent forward before the close of navigation than was shipped in 1905, although a fortnight ago, vessels were hopeful the business out of Port Arthur and Fort William this fall would exceed all previous records.

Attorney-General Morris, speaking at the same function, said that the colonial government was unaware of the terms of the modus vivendi, but it had done everything within its power to protect the colony.

Today the Telegram, the Premier's organ, ascribes the policy of timid Downing street bureaucrats, and expresses the hope that the Newfoundland Government will show the spirit of determination, and teach little Englanders like Lord Elgin and Winston Churchill the same lesson that the colonists of Natal taught them when they tried to ride rough-shod over that colony a few months ago.

The Herald prints a letter of Congressman Gardner, who represented the Americans' fishing interests at Washington, published last July, wherein Mr. Gardner is quoted as admitting that American vessels have the right to ship Newfoundlanders in their crews. The paper then observes that, in view of this letter, the British Government's action in granting such a concession is incomprehensible.

Lakes Storm-Swept.
Detroit, Mich., Oct. 9.—Reports from Sault Ste. Marie today say that the Lake Superior country is being swept by a northwest gale and snowstorm, and that navigation is both difficult and dangerous owing to snow. Steamers coming up from Lake Erie report that last night's storm was very severe. The passenger steamer Western States arrived two hours and a half late from Buffalo, and reported a terrific battle all the way across the lake with a 50-mile gale.

The steamer A. Weston, bound down with lumber and towing a barge, was forced to tie up here last night by the refusal of the crew to continue working if the boat passed Detroit. The Weston's wheel was broken, and the boat could make between five and six miles an hour, and the crew refused to venture out on Lake Erie in the storm with the boat in that condition. The captain complied with their demands.

**TWO THIEVES
SENT TO CENTRAL****McMullen and Duckworth Come
Up for Sentence—Other
Cases Dealt With.**

James C. Lytle and Thomas Duckworth, who were found guilty some time ago on a charge of stealing \$140 from Duckworth's employer while he was in a state of intoxication, appeared at the police court this morning for sentence. James Lytle, who has previously been of good character and whose downfall has been due to drink, was sentenced to two months in jail with hard labor. Duckworth who has told several different stories since his arrest told another this morning which looked far from possible to the court. He was sentenced to five months in the Central Prison.

Ralph McMullen, the young man who was caught attempting to steal from a roommate some time ago, and who had also against him a charge of stealing a valise from the G. T. B. station in Toronto, appeared for sentence and was sent to the Central Prison for twelve months. McMullen has several times been convicted of dishonest actions, and the magistrate pointed out when passing sentence upon him that he has evidently made up his mind to follow a criminal career and has started young, being only 17 years of age.

Richard Johnston was fined \$20 or two months for assaulting his wife. Maurice Baldwin appeared to answer to a charge of breach of bylaw and was discharged on suspended sentence. The charge was that of leaving some wagons on Queen's avenue, where they obstructed the highway.

Four first-time drunks appeared and were allowed to go.

One citizen appeared to pay his dog tax.

Two abusive language cases were to have come up, but the charges were dropped.

LEADERS SUBPOENAED

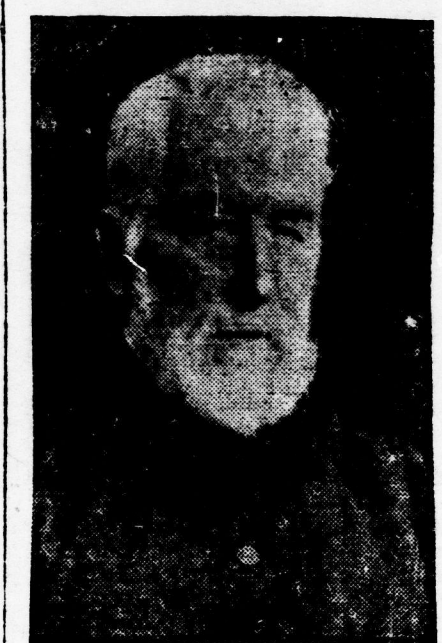
Messrs Scott and Oliver Called as Witnesses in London Election Case.

Toronto, Oct. 9.—Hon. Frank Oliver, minister of the interior, and Hon. Walter Scott, premier of Saskatchewan, are to be called as witnesses in the London bribery cases. Subpoenas were sent through the local police department Sunday night to Ottawa at the instigation of Mr. Eric Armour, who has been associated in the crown work at the hearing. Mr. Scott is in Ottawa at the meeting of the provincial premiers.

It is alleged that these two Liberal leaders were in the constituency three weeks before the bye-election of June, 1905. "Tom" Lewis will be recalled, while it is also said that nearly every member of the Liberal organization in London will be subpoenaed.

Snow in the Catskills.
New York, Oct. 9.—Snow squalls were reported in the Catskills yesterday. For a time the ground was covered with snow.

Accused of Big Steal.
Montreal, Oct. 9.—A reward of \$500 is offered for information leading to the apprehension of James Stewart, a Catholic, defaulting teller of the Bank of British North America. Chief Carpenter holds the warrant for the arrest and on it the amount alleged to have been stolen by Stewart is put down at \$5,500. This represents a sum supposed to have been stolen on one occasion. The total amount involved is said to be about \$25,000, extending over a period of several months.



THE LATE ARCHBISHOP BOND.
Anglican Primate of All Canada, Died
This Morning at Montreal, in
His Ninety-first Year.

"AL" ADAMS MURDERED?**Coroner Declares that Famous Policy
King Was Not a Suicide.**

New York, Oct. 9.—That Albert J. Adams, the so-called "policy king," who was found dead in his rooms in the Hotel Ansonia, was murdered, is the belief of Coroner Harburger, as expressed at the opening of the inquest into Adams' death today. The coroner also said that his investigation would also reveal evidence to show that the murderer is a prominent witness in the case.

A NEW PARTY**Organized With Purpose of Promoting
Maritime Union.**

St. John, N. B., Oct. 9.—A new political party is being formed in New Brunswick, having in view its prime object maritime union. The party will be independent, having a leaning towards the Liberal side of politics. The intention is to have a ticket in every county in the province to support its interests. A ticket is already formed in King's County. Dr. McVey, of Rothesay, and Mr. Freeze, of Sussex, are two of the candidates. It is also understood that two politicians in St. John have formed themselves into a ticket, and will contest this constituency in the interest of the new party.

GREAT WORK DONE**Many Improvements Still Being Made
on St. Lawrence.**

Quebec, Que., Oct. 9.—The Dominion marine and fisheries department have done great work during the season of navigation just drawing to a close, that will eventually prove very valuable to the shipping interests of the lower St. Lawrence route. Hon. L. P. Brodeur has done much to help the shipping interests at home and abroad. In the Straits of Belle Isle a new light-house and fog alarm system have been installed with water connection, and at Forteau Bay and Greenley Island similar work will be completed this fall and in operation next spring. A new light-house, waterworks and fog alarm system in course of erection at Belle Isle will also be finished this fall, likewise similar aids to navigation at Cape Bell and Cape Norman. At Cape Anglich, Newfoundland, extensive works are being constructed, including a fog alarm system and keeper's dwelling, that will be finished next year. The new station at Cape Ray and the light-house systems at Cape Magdalen and Martin River are completed.

Bishop I. O. Stringer and Rev. A. E. O'Meara are in Toronto at present, having come from the Yukon to attend the semi-annual meeting of the board of management of the Missionary Society of the Church of England, which will convene on Thursday morning in Cronyn Hall, this city.

**WOULD RUN CITY
BY COMMISSION****Mayor Said to Favor Plan
of That Nature.****COUNCIL TO ACT AS SENATE****Ex-Mayor Wilson Points Out How Lon-
don's Business Could Be
Better Managed.**

According to a statement made by ex-Mayor John D. Wilson, who visited the city hall today, it is the intention of Mayor Judd to move for a change in the manner of city government shortly.

"I have reason to believe," Dr. Wilson said, "that his worship has been convinced that the present system of government by the council is not satisfactory, and that he will shortly make a move in the council to have a commission appointed."

Mayor Judd was away in Toronto today, and he could not be seen. Ald. Forristal is again acting mayor.

Dr. Wilson has advanced ideas on the matter of civic government, and he believes that it is time for a change.

Too Many Boards.

"It has been my experience as mayor of the city that there are too many boards," Dr. Wilson said. "There are altogether too many spending bodies, and the result is that the city's business is not run as it should be run. The mayor and aldermen have not the time to run the city's affairs as they should be run. No matter how good and how honest they may be, they have their own affairs to look after, and it is too much to expect that they will devote the time to city business which properly belongs to their private businesses."

Water Commission a Farce.

"I also consider the water commission a farce, and I say this as one who spent two years on the commission. To say that three men can meet for ten or fifteen minutes every two weeks and run the business of the waterworks properly is ridiculous. It can't be done."

"My idea, and I think the mayor thinks along similar lines, would be to amalgamate the council, board of health, water commission, etc. I would have five commissioners appointed and paid good salaries, so that they would be able to devote their entire time to the business of the city, and I would have the aldermen elected as a sort of senate which would have final powers over the commission."

The doctor thinks that under such a system of government the city's affairs would be better administered, and the money of the taxpayers would go further.

It is pretty well agreed that the majority of city business is done by the officials, and that the different civic boards simply authorize or excuse automatic expenditures. The council does not manage it. It is not the time, the mayor daily signs bundles of checks for expenditures which it is impossible for him to inquire into, and it has happened around the city hall that his worship has authorized the payment of hundreds of dollars of which he was not aware.

Too Much Politics.

Dr. Wilson was very outspoken today, and he did not hesitate to declare that there is too much politics in London's civic government.

"I know it by experience," he said. "It was the same on the school board. I have known of instances in which a teacher was to be appointed, and before a decision could be come to it was necessary to inquire how her father voted. This, to me, is ridiculous."

Dr. English, of the board of education, was present, and he claimed that things have been different the past couple of years. When asked if it was not a little peculiar that the majority of male teachers in this city are of the same shade of politics, Dr. English laughingly declared that of the male teachers who apply for positions, the good ones are on his own side of the fence.

Dr. Wilson concluded by asserting that he would have no hesitation in voting for the taking over of the London street railway if the proper men were placed on a board of five to run the city's affairs.

DEATH OF ADELAIDE RISTORI**The Famous Italian Actress Succumbs
to Pneumonia.**

Rome, Oct. 9.—The Marzha Del Grillo, better known as Adelaide Ristori, the celebrated Italian actress, died early this morning of pneumonia.

A GRIM TRAGEDY.

Steubenville, O., Oct. 9.—His home destroyed by flames and the dead bodies of his aged father and two small children was the sight which met the eyes of Charles Zende, a farmer on McIntyre Creek, when he returned from a short trip late yesterday. All were found near a door leading out of the house, and had evidently been suffocated by the smoke.

**Death of Archbishop Bond;
Anglican Primate Passes****Head of the Church in Canada Dead at Montreal
in His Ninety-First Year.**

Montreal, Oct. 9.—Archbishop the Most Rev. William Bennett Bond, D.D., LL.D., metropolitan primate of the Anglican Church in Canada, passed away this morning in his 91st year.

Rev. Dyson Hague's Appreciation.
Rev. Dyson Hague, rector of the Memorial Church, who for many years prior to his removal to London was a resident of Montreal, and a warm friend of Archbishop Bond, paid the following tribute to the deceased:

"Archbishop Bond was undoubtedly the foremost man in the Church of England in Canada today. He was the grand old man of the church. His career was unique. No other man probably in the history of the Church of England from the days of the apostles has had so extraordinary and unchecked a career. He has passed

through every possible phase of church advancement, and today, at the age of 92 years, he leaves a name that is as great as it has been unstained.

"Archbishop Bond began as a lay reader; then became a catechist, then a deacon, then a curate, then a priest; then a rector, then a canon, then an archdeacon, then a dean, then a bishop, then an archbishop, and finally the metropolitan primate of the church in Canada.

"He was of sound and unchangeable evangelical convictions, and no man in the Canadian Church has so consistently and courageously preached, through the course of many years, the simple gospel of Jesus Christ."

"No man wavered less. From the start he took a firm stand for the old traditional principles of the Church of England, and from that stand he never

**IT'S RIDICULOUS,
SAYS MR. TOOTHE****No Truth in the Story of Mid-
night Conference With
Tom Lewis.**

The Toronto News, which has printed more "fake" material about the London election case than all other journals combined, publishes a sensational story of a midnight conference between R. M. C. Toote, Charles Toomey and Thomas Lewis, and adds: "It is understood that Tom Lewis intimated his willingness to tell the story of the bye-election as he knew it, if he were released from the alleged pending action for perjury, and if his relatives employed under the Dominion Government in the customs and postoffice were not thrown out, as has been threatened if he told his story."

Mr. Toote says that the story is for the most part a fabrication. He saw Tom Lewis for a short time on Saturday night, but it was on private business. It appears that both of them have financial interests in the Ironquits Hotel. The tale of a midnight conference lasting until 1:30 a.m. Sunday, as related in the News, is described by Mr. Toote as ridiculous. He refused to say anything to the News reporters who were in the city and they merely guessed at things.

DEVASTATED BY FIRE**Flames Destroy Vast Tract of Cali-
fornia Timber Lands.**

Los Angeles, Cal., Oct. 9.—The changing of the wind saved the town of San Fernando from certain destruction from the mountain fire, which raged intermittently early Friday morning, until late yesterday afternoon. Sixty square miles of steep and valley lands, it is estimated, were burned over last night, and until the subsidence of the flames, yesterday afternoon, and it is said that in all 250 square miles have been devastated.

WORK OF THE WIND**Telephone Wires Suffered Severely By
Last Night's Storm.**

The storm of last night did considerable damage in this section. Throughout the city trees were blown over or branches snapped off, and many sidewalks were blocked during the night and this morning.

Local "phones" suffered severely through trees and branches falling across the wires and breaking the connection. Several long distance lines were also put out of business in the same manner by the storm.

Messages from outside places in this section say that the wind was very strong for several hours, and that much damage was done to fences, buildings, etc.

The lighting wires of the London Electric Company were in several places crossed with other wires, and a great deal of trouble was caused the company, but though many lamps were in darkness throughout the night, the majority were kept burning. The company reports the damage done as small.

The London Street Railway kept its cars moving, despite the fact that it is working on only half capacity, as a new commuter is being installed at the power house.

**M'BRIDE ASKS FOR
SPECIAL TERMS****British Columbia Run at Heavy
Cost—The Premiers Still
Talking Subsidy.**

Ottawa, Oct. 9.—The Provincial Conference met at 10 o'clock this morning. At 11 o'clock Sir Wilfrid Laurier and Messrs. Aylesworth, Fielding and Le-mieux entered the committee room, but as the provincial representatives had not adopted the resolution framed by the subcommittee yesterday evening, the Dominion ministers retired. The conference saw no prospect of being ready to meet the Dominion earlier than the afternoon, and probably not until tomorrow.

It is said that British Columbia is holding forth today and that the other provinces are fairly well satisfied. Premier McBride is insisting upon special terms for his province, because of the increased cost of administration on account of difficulties connected with the Government. There is talk from that province of a commission being appointed to look into its position, so that better terms may be secured.

William K. Vanderbilt, jun., Jefferson De Mont Thompson, and A. R. Pardington were selected. The indications are that the plan will be carried out. The committee intends to secure a course that will give a racing circuit of from 25 to 30 miles.

**Bullet of Jealous Wife
Wounds Sultan Hamid**

Paris, Oct. 9.—A dispatch to the Petit Parisien from Constantinople declares that the real secret of the recent illness of the Sultan of Turkey was that he was shot in the abdomen by a Kurdish woman, who was jealous of his latest favorite in the harem, a beautiful Circassian girl. According to the story the bullet was extracted by a German physician, the Sultan going under the operation without taking chloroform and displaying great nerve.
