Three Pounds shall be paid over to the Managers of the Ministers' Widows' and Orphans' Fund, and their receipt shall be received by me in lieu of the same.

Minister of -

And further, Presbyteries are enjoined not to ordain or induct any Probationer or Minister into a Pastoral charge, without his first having signed the above Bond in the presence of the Presbytery, and which Bond shall be attested by the Moderator and Clerk.

And further, each Minister is enjoined to have a yearly collection on the first Sabbath of January in behalf of said Fund, and to use all diligence to obtain donations or subscriptions from his people, to be paid to the Treasurer of the Fund:—and Presbyteries are enjoined to see that Ministers show all diligence in this matter, and send yearly returns to the Synod.

The Synod agreed that the first instalment for the Widows' and Orphans' Fund shall be payable on the First day of January, 1848:—and the Synod's Clergy Reserve Commissioners are required to see that the Bonds are forwarded to them in due time.

The Committee appointed to prepare an Address to His Excellency the Governor General reported a Draft, which was read and considered. The Synod adopted the same, and ordered it to be engrossed for the Moderator's signature.

The Synod called for the Reports of the Committees appointed to revise the Records of the Synod and Presbyteries. A Report on the Synod Records was given in, read and sustained:—and the Synod ordered the Records to be attested by their Moderator, as carefully and correctly kept. Reports were given in on the Records of the Presbyteries of Montreal, Glengary, Hamilton, Bathurst, Kingston, and Toronto. The same were read and sustained, and the Synod ordered their Clerk to attest the Records of these several Presbyteries, as carefully and correctly kept. A Report was given in by the Committee on the Commission Records, recommending, in regard to the Minute of the 22nd of October, 1845, that it be deleted. The Synod sustained the Report, and ordered that the said Minute be deleted, and that it be marked in the margin that it was so deleted by order of the Synod of this date.

The Synod adjourned till to-morrow morning at Ten o'clock; and was closed with prayer.
