**AUTOMOTIVE INDUSTRY****TAX POSITION OF DOMESTIC CAR LEASING COMPANIES—  
MOTION UNDER S.O. 43**

**Mr. Joe Reid (St. Catharines):** Madam Speaker, under heavy pressure the Minister of Finance (Mr. MacEachen) has agreed to revise the capital cost allowance rate to assist about six multinational car rental companies while continuing to penalize and discriminate against some 2,200 Canadian auto dealers in the car leasing business. Whereas these Canadian auto dealers employ over 75,000 Canadians, which dealers are already hard hit by slumping sales and mounting overhead costs, I move, seconded by the hon. member for Brampton-Georgetown (Mr. McDermid):

That the minister practise the equity he preaches by extending the capital cost allowance rate increase recently given the six multinationals to the 2,200 Canadian-owned dealerships which lease their cars on a monthly and yearly basis, not by the day.

**FISHERIES****CHINOOK SALMON FISHERY ON FRASER RIVER, B.C.—MOTION  
UNDER S.O. 43**

**Mr. Mark Rose (Mission-Port Moody):** Madam Speaker, I too have a motion under Standing Order 43. Because of the steady decline in the stock of Chinook salmon the Department of Fisheries is contemplating a complete closure of the Fraser River gillnet fishery this season, meaning a tremendous loss of income for all fishermen, especially for the Katzie Indian band which depends on fishing for 90 per cent of its income. I therefore move, seconded by the hon. member for New Westminster-Coquitlam (Miss Jewett):

That to ensure that Chinook conservation is shared by all other user groups, a 24 hours per week fishery be permitted from April until November, and failing this demand, that gill-netters be given full compensation for lost fishing time and redundant gear of \$10,000 per licensed boat.
