12. It shall be lawful for the said Council, or a majority of meetings, how them, by a notice inserted in one or more newspapers published in the said town of St. Catherines, one day previous to the said 25 meeting, or by a circular letter signed by the secretary of the said Corporation addressed to each member, and mailed one day previous to the said meeting, to call a general meeting of the said Corporation for any of the purposes of this Act.

13. It shall be competent for the said Council, to hold meetings, 30 from time to time, and to adjourn the same when necessary, and at the said meetings to transact such business as may, by this Act. or by the By-laws of the Corporation be assigned to them, and such meetings of the Council shall be convened by the secretary at the instance of the President or upon the request of any four 35 members of the said Council, and the said Council shall, in addition to the powers hereby expressly conferred on them have such powers as shall be assigned to them by any By-law of the Corporation, except only the power of enacting or altering any By-law, or admitting any member, which shall be done in the manner 40 provided for by this Act, and in no other; and any seven or more members of the Council lawfully met (and of whom the President or Vice President shall be one, or in case of their absence any seven or more members lawfully met) shall be a quorum, and any majority of such quorum may do all things within the power of 45
