

Thaw Again Free After Nine Years
New York, July 16—Harry K. Thaw, who shot and killed Stanford White, on the night of June 26, 1906, walked from the courtroom a free man at noon to-day.

Justice Hendrick accepted the finding of the jury that declare Thaw sane and immediately after announcing the decision admitted Thaw to \$35,000 bail. Warned by the deputy marshalls the big crowd in the court room attempted no demonstration. Thaw himself sat unmoved by the decision. When the court overruled the state's attempt to block his release on bail, he turned on Deputy Attorney General Cook a quiet smile of triumph. His nine years' fight for freedom had been won, but Thaw was the most undemonstrative person in the great crowd in and around the Supreme Court Building.

The state immediately entered an appeal from Justice Hendrick's finding.

Illegal Branding of Whey Butter
Owing to the fact that considerable quantities of whey butter are being made in Eastern Ontario, the chief inspector of dairy products, J. E. Singleton, is watching the matter of wrongful branding of the product. It is illegal to do so. To put a stop to the practice which has an injurious effect on the reputation of the industry generally, prosecutions have taken place that should prove a warning to others.

In this connection at Morrisburg, on July 8th, Glen Becker Cheese and Butter Co., of that place, pleaded guilty before Police Magistrate Wm. Eager to the charge of branding whey butter as creamery butter.

The same day Wm. Gogo, butter dealer, of Morrisburg, for whom the whey butter had been falsely branded, pleaded guilty to having knowingly sold whey butter branded as creamery butter.

A fine of ten dollars with costs was imposed in each case.

Gananogue Reeve Resigns
On Wednesday last, Mr David Darling handed in his resignation as Reeve of Gananogue, to Mr S. McCammon, Town Clerk. This action on the part of Mr Darling is the result of bickerings at the Council meeting and fault being found with some of his work. He says he retired from business to get rid of petty worries, and he does not propose to star in the Council and have them increased. We do not know, of course, what the result will be when the matter comes before the Council, but it will be a difficult matter to find a man who will give the same time and attention to the work on streets that Mr Darling has done.

Two Waders Drowned
Deseronto, Ont., July 15—Miss Mae Bartley and Mrs O. M. Madden were drowned this evening while wading off the shore of Forrester's Island, having got over their depth. Mrs Madden was married about two months ago. The bodies were in the water nearly thirty minutes before boats from town brought help.

Kingston Fireman Hurt
Kingston, July 18—Capt. Frederick Reid, of the city fire department, was seriously hurt this afternoon when a fire extinguisher, which he was using at a small blaze that started in the barber shop of W. Deline, Wellington street, exploded. He was knocked unconscious and suffered terrible cuts about the face. He was removed to the General Hospital.

New Taxes in Ontario are to be Imposed
Toronto, June 15—That the Province of Ontario will impose new taxes in the shape of direct provincial taxation, for the purpose of providing the revenue which is required to cover large provincial undertakings is evident from the appointment of a department of taxation under the provincial treasury, with J. T. White as commissioner of taxation. The commissioner has been a member of the firm of Millar, Ferguson & Hunter and enters on his new duties next week.

Just how far the taxation will go is a matter of policy which it is understood has not yet been determined, but the probability is that for some time at any rate it will be confined to the taxation of corporations.

Investigation will be made to discover where the burden can best be laid, and a bill will then be presented to the legislature to provide the necessary authority for what changes are necessary.

It is probable that the new scheme will cover such corporations as the Ontario Jockey Club, which makes large earnings during the short season of its activity.

Hon. T. W. McGarry, Hon. Howard Ferguson, and the commissioner leave shortly to attend the conference of the National Tax Association at San Francisco.

Ottawa Schools Under Commission
Following the decision of the Ontario Supreme Court, confirming the stand taken by the Ontario Government upon its bilingual regulations, the Government, it is understood, is now preparing to appoint a commission to administer the affairs of the Ottawa Separate schools. It is stated that the appointments will be made in the near future, but the personnel of the new body has not been definitely decided upon.

The appointment of a commission was provided for in legislation last session. The government brought in a special bill giving the Minister of Education power to appoint a commission to take over complete control of the schools should the Ottawa Separate School Board, in which the French-speaking element is supreme, refuse to obey the school regulations. The rebellious majority has remained defiant however, and a month or two ago the government, unwilling to proceed under the special Act while the decision of the courts upon the general question was pending, found a temporary way out by advancing the salaries of the teachers in schools obeying the regulations—practically the arrangement was carried through to the end of the term, but it is recognized that a more permanent plan must be adopted before the next term opens. The favorable judgment of the court strengthens the Government in its determination to deal firmly with the problem.

Many Horses Stricken
Commissioner of Agriculture Charles Wilcot of Cornwall, has placed under quarantine the towns of Brasher and Massena, in St. Lawrence County, and the towns of Bombay and Fort Covington, in Franklin County, for infectious anaemia, or swamp fever, a horse disease. The St. Regis Indian reservation also is under quarantine, where 150 horses are affected. The quarantine prohibits the removal of any horse from the territory or the removal of any horse affected with the disease from the premises on which they now are. Last fall a horse disease became prevalent in the vicinity of Hogansburg, and a number of horses died. A peculiar thing about the disease was that no horses were affected that had not been in the pasture.

Death of Mrs. Liddell
The death occurred at Cornwall on Friday, after a lengthy illness, of Margaret MacDonell, wife of J. W. Liddell, Junior Judge for the united counties of Stormont, Dundas and Glengarry. She was in her 56th year. She was a daughter of Ranald MacDonell, a pioneer of the district. Mrs Liddell is survived by her husband, one son, Percy, of Vancouver, B.C., and two daughters, Mrs W. A. Mattice, Ottawa, and Mrs C. H. Carter, Bridgewater, N. S. The funeral took place on Sunday afternoon.

The Late Mr. Whitmarsh
Mr A. Whitmarsh, a highly esteemed resident of Merrickville, died at the Public Hospital, Smith's Falls last Saturday after an illness of some duration from liver trouble. Deceased was formerly a resident of Gananogue and enjoyed the good will of all his acquaintances. Mrs (Dr) Bedell, of Merrickville, is a daughter, from whose home the funeral took place on Monday.
