CEALED TENDERS addressed to the undering signed and endorsed "Tender for the Welland Canal," will be received at this office until the arrival of the Eastern and Western mails on MONDAY, the 25th day of JANUARY, next (1886), for raising the walls of the locks, weirs, etc., and increasing the height of the banks of that part of the Welland Canal between Port Dalhousie and Theod, and for deepening the kumplit fovel between Thorold and Ramoy's ilpud, near Huthberston.
