CANADIAN FLAG

REPORTED ACCEPTANCE OF DESIGN BY CABINET

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I should like to ask the Prime Minister whether there is any basis in fact to the press report that the personal flag to which he has given his support has now been accepted by the cabinet.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, there is no basis for any statement that any personal flag of anybody's has been accepted. There is basis for the statement that the cabinet decided this morning on a design, which it will shortly submit to parliament in the form of a resolution.

Mr. Aiken: A supplementary question—

Mr. Diefenbaker: I would be glad if the hon. gentleman asked his question, but first of all I should like to know if the Prime Minister will tell us whether this is the flag he exhibited to a group of newsmen last Thursday night at his home, and did he at that time say "This is my personal choice as a flag design"? Did he also say that he had sent a telegram to the Queen informing her that the red ensign would not be the Canadian flag?

Mr. Pearson: No, Mr. Speaker.

Some hon. Members: Oh, oh.

Mr. Diefenbaker: Mr. Speaker, some of those who are laughing at the moment are not laughing inwardly. May I ask the Prime Minister this. Did he on Thursday night meet at his home with a select group of six members of the press gallery, show them a model flag, and state that this was his personal choice?

Mr. Pearson: Mr. Speaker, I did meet with certain members of the press at a social occasion; I do not deny that. Indeed, the right hon. gentleman does that himself quite frequently. I hope that when he meets his friends from the press at his home they have as good a time as I hope they would have at my home. Mr. Speaker, we had a cup of tea, and there was some discussion of the question of national emblems. The national flag issue certainly came up, and I expressed in a personal way to my friends my views on that subject.

An hon. Member: Are you afraid of it?

Mr. G. W. Baldwin (Peace River): I have a supplementary question for the Prime Minister.
