ESTATE TAX ACT

CONSULTATION WITH PREMIERS BEFORE PROCEEDING FURTHER WITH MEASURE

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I was going to ask the Minister of Finance a question, but he ran out when he realized it. I see however that he is now returning. I should like to ask him whether, as a result of the conversations his government has had with the provincial premiers, he can now advise the house if any decision has been made by him or by his government to consult with the provinces before proceeding any further with the estate tax measure?

Hon. E. J. Benson (Minister of Finance): No, Mr. Speaker.

Mr. Speaker: The right hon, member for Prince Albert.

Mr. Benson: Mr. Speaker, if I might just complete my answer—

Mr. Speaker: Order. The hon. minister may not do so without leave of the Chair, and the Chair has already recognized the right hon. member for Prince Albert.

Mr. Benson: Mr. Speaker, I would simply like to make my answer more complete.

[Mr. Speaker.]

When I answered the question put by the hon. member for Calgary North, I simply said no. What I should have said was no, there were no requests for further consultations from the provincial finance ministers.

Mr. Woolliams: A supplementary question, Mr. Speaker. I do not want to get into an argument over this, but let me ask the minister this. Whether there has been a request, or there has not, would the minister consider approaching the provinces to see if they do consent to his estate tax measure as it affects property and civil rights?

Mr. Benson: Mr. Speaker, the estate tax was introduced before the ministers of finance meeting in December. At that time I indicated that I would be glad to discuss the matter with any finance ministers who were interested. I received representations from one province, which I answered before we proceeded with the bill.

Mr. Woolliams: A further supplementary question. Could the minister tell the house whether he has had a complaint from the province of Alberta, that his department is taxing the refund of estate tax that is made by the province?

Mr. Benson: Mr. Speaker, this is incorrect. I have not had a complaint, but I have heard such rumours. As I say, this is of course incorrect.

Mr. R. N. Thompson (Red Deer): Mr. Speaker, I have a supplementary for the Minister of Finance. It is reported that income tax officials are taxing estate tax refunds as income. Would the minister kindly check on this and let us know formally in the house?

Mr. Speaker: Order, please. The hon. member should direct his question to the Chair. In any event he has made a representation to the minister.
