# CANADIAN WORLD EXHIBITION CORPORATION

MEASURE WINDING UP EXPO

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce) moved that Bill C-6, to wind up the Canadian Corporation for the 1967 World Exhibition and to authorize the writing-off of certain costs and the deferral of certain payments connected therewith, be read the second time and referred to the Standing Committee on Finance, Trade and Economic Affairs.

Mr. Stanley Knowles (Winnipeg North Centre): On a point of order, Mr. Speaker, I wonder whether I might raise a question concerning what we do under this new régime whereby all the members do not have files of bills at their desks. I confess I have mine, as have a few others, but if we are not to have files of bills at our desks, I wonder whether a copy of a bill that is to be discussed on any particular day should not be placed on members' desks.

Mr. Speaker: The point is well taken. It was my understanding that copies of the bill would have been distributed, particularly today since the business had been announced previously.
