AIRPORTS

PICKERING TOWNSHIP SITE—MINISTER'S POSITION ON DECISION IN LIGHT OF OBJECTIONS—PROVISION OF INFORMATION

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I should like to direct my question to the Minister of Transport. Does the minister still stand by his original decision regarding the need for a second international airport, as well as the choice now before us as being the best possible, in view of mounting objections in regard to both decisions?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, the answer to both questions is yes. I might also call to the hon. member's attention the mounting degree of support for the proposal.

Mr. Alexander: I am appreciative of the minister's answer. In this regard I am with him, though I am seldom with the government on anything. In view of the fact the minister has given an undertaking to table the necessary studies and what-not that enabled him to make these decisions, when is he going to follow through on his undertaking? I believe it is extremely important for the members of the House to know the thinking of the government so we can answer the letters we are receiving on the matter.

Mr. Jamieson: Mr. Speaker, I suspect that the hon. member was not in the House some two weeks ago, I believe it was, when I indicated that the material was available and that any hon. member who wished could get it in any quantity he required. My reason for not making a general distribution was simply to try to save money by not sending it to people who were not interested in it.

Mr. Alexander: A further supplementary question, Mr. Speaker. I must say this is a new approach. In view of the [Mr. Lang.]

interest in this matter, I thought the documents would be tabled. Would the minister take it upon himself to publicize the documents so that the whole nation will know what we are talking about?

Mr. Jamieson: Mr. Speaker, I think that has been done, but if the hon. member has additional ways in which he wishes to have this done I shall be glad to comply. In the meantime I will table the documents.
