Harold Samuel Gerson:

Verdict of October 11, 1946, set aside by Ontario Court of Appeal and at a second trial, found guilty on October 9, 1947, of conspiracy to commit an offence under the Official Secrets Act and sentenced to four years imprisonment.

James Scott Benning:

Appeal allowed and conviction quashed by Ontario Court of Appeal, April 24, 1947.

David Gordon Lunan:

Appeal dismissed on February 28, 1947. Also sentenced to one year for contempt of court for refusing to testify in the prosecution of Israel Halperin, which term to be served consecutively.

Philip Durnford Pemberton Smith:

Appeal dismissed by Ontario Court of Appeal on April 24, 1947.

Frederick Poland:

Acquitted on first charge on January 16, 1947. Second charge dismissed.

Israel Halperin:

Acquitted on March 4, 1947.

Henry Harris:

Found guilty on January 27, 1947, on two charges of conspiracy under the Official Secrets Act and sentenced to five years imprisonment. Appeal allowed by Ontario Court of Appeal on May 27, 1947, and conviction quashed.

Raymond Boyer:

At first trial, jury unable to reach verdict on March 31, 1947. At second trial, found guilty and sentenced to two years imprisonment on January 31, 1948. Appeal dismissed by Ontario Court of Appeal on November 30, 1948. Subsequent petition for leave to appeal to Supreme Court of Canada dismissed on December 17, 1948.

Sam Carr:

Found guilty on April 8, 1949 (after extradition to Canada from the United States) on a charge of conspiring to utter a false document contrary to the provisions of the Criminal Code and sentenced to six years imprisonment. Appeals to Ontario Court of Appeal dismissed on September 27, 1949.

Freda Linton:

Surrendered to RCMP on April 11, 1949. Charges withdrawn by the Crown on May 3, 1949, due to insufficient evidence.
