POINT OF ORDER

MR. STEVENS—ALLEGED IRREGULARITY OF ESTIMATE BEFORE STANDING COMMITTEE—RULING BY MADAM SPEAKER

Madam Speaker: Before we proceed to the Orders of the Day, I would like to rule on the matter that was raised by the Hon. Member for York-Peel (Mr. Stevens). He raised a point of order on the propriety of votes 26b and 27b under Industry, Trade and Commerce in the Supplementary Estimates (B) for the fiscal year ending March 31, 1983. The two votes concern payments of an equal amount of \$200 million as equity each to Canadair Limited and the de Havilland Aircraft of Canada, Limited. The Hon. Member argued that they are incorrect and not in a proper form to be voted on, and should therefore be deleted from the Estimates. I would like to thank all Hon. Members who contributed arguments on this very technical question.

I should remind Hon. Members once again that the Chair's responsibilities lie strictly within the realm of parliamentary procedure and not within the sphere of legality. With respect to the items in the Estimates, it is the Chair's duty to ensure that such items are based upon legislative authority. In the case before us, I have examined each item carefully and can conclude that each is based upon a legislative authority; namely, vote 26b upon Appropriation Act No. 3, 1975 and vote 27b upon Appropriation Act No. 4, 1973. Both votes are therefore properly before the House. In any case, there were no procedural objections raised against them as they appear in the Blue Book.

Hon. Members have argued that the announcement of the transfer of certain commercial assets and enterprises of Canadair and de Havilland to the Canada Development Investment Corporation would have the result, in their words, of nullifying votes 26b and 27b. But in so far as the Chair is able to determine, the announcement of the creation and involvement of the CDIC does not appear to change the existence of Canadair or de Havilland. It is my view that this aspect of the question resolves itself into a matter of debate and, as Hon. Members are aware, the role of the Chair is not to become involved in any such debate.

The question of the two Crown corporations being placed under the responsibility of a new Minister has also been raised. Let me put that argument to rest by stating that the transfer of the responsibility from Industry, Trade and Commerce to Social Development has no bearing upon the actual items or under which headings they are placed in the Blue Book of Estimates. For the benefit of all Hon. Members, I should quote, in part, from Beauchesne, Citations 484 and 487(2):
