NATIONAL ADVISORY COMMITTEE ON YOUTH

Ouestion No. 418-Mr. Robichaud:

- 1. Did the Minister of State (Youth) select a young English-speaking person to represent New Brunswick on the National Advisory Committee on Youth and, if so (a) did the Minister consult youth organizations in New Brunswick before making her choice (b) did the Minister consider the possibility of recognizing New Brunswick's French speaking community during the selection of the committee's members?
- 2. Will the Minister change her mind in order to appoint a young French-speaking member to the committee and, if so, on what date?

Hon. Andrée Champagne (Minister of State (Youth)): 1. The Minister of State for Youth selected a group of 24 young people from across Canada to act as her advisors on an International Youth Year Advisory Committee. The committee has a mandate to: attend various International Youth Year events; facilitate the development of the International Youth Year federal youth forums; advise the Minister on matters of interest and concern to Canadian youth which arise during the Year.

The committee members were chosen on an individual basis to reflect the various interests and backgrounds of young men and women as well as the different regions, and linguistic and cultural groups in Canada. The members do not represent a specific region or group. One of the members is from Saint John, New Brunswick. While she is bilingual, her mother tongue is English.

- (a) The Minister selected these members based on suggestions received from her departmental officials, various groups and individuals from across the country.
- (b) The possibility of selecting a French-speaking youth from New Brunswick was considered as was the possibility of selecting French-speaking young people from other provinces and other linguistic and cultural groups.
- 2. There are seven French-speaking committee members, two of whom come from French-speaking communities outside of Quebec (i.e, Ontario and Saskatchewan). At this time, the Minister is not planning to appoint additional members to the committee. However, the Minister has appointed Martin Pitre of Robertville, New Brunswick, as an International Youth Year ambassador.
