Oral Questions

NATIONAL PARKS

PACIFIC RIM NATIONAL PARK—OPPOSITION TO TOLL-GATE PROPOSAL

Mr. Ted Schellenberg (Nanaimo—Alberni): Mr. Speaker, my question is directed to the Minister of the Environment. The Minister will be aware that Parks Canada plans to install a toll-gate at Pacific Rim National Park in my riding. The local community believes that this will damage the tourism industry, and it will probably not be cost effective due to the remoteness of the area. Why is a toll-gate necessary in the Pacific Rim National Park? Will the Minister reconsider the decision to install that toll-gate?

Hon. Tom McMillan (Minister of the Environment): There has been in place for a long time a general policy to charge entrance fees at the most heavily patronized national parks. In this case we are applying the policy because the Pacific Rim is one of the most popular parks. The B.C. Government, and the Hon. Member, have made the argument that, because the federal Crown owes the provincial Crown some \$25 million in connection with outstanding issues surrounding that park, we ought not to be charging entrance fees until the bill is paid.

In a few days time I will be flying to British Columbia to speak to my opposite number, Stephen Rogers, the Minister of the Environment and Parks, to discuss the question. I will certainly take the Hon. Member's own views into account when I attend the meeting.
