ENDANGERED AND THREATENED SPECIES ACT

MEASURE TO ENACT

Hon. Chas. L. Caccia (Davenport) moved for leave to introduce Bill C-209, an act respecting the protection and rehabilitation of endangered and threatened species.

He said: Mr. Speaker, this act intends to protect and rehabilitate endangered and threatened species. In essence, it attempts to identify, protect and rehabilitate flora and fauna in Canada which are threatened or endangered by human activity; to develop and implement programs to restore the populations of threatened and endangered species of flora and fauna in Canada to self-sustaining numbers; and to provide legislative support to voluntary programs.

Motion agreed to, bill read the first time and ordered to be printed.

CANADIAN HUMAN RIGHTS ACT

MEASURE TO AMEND

Mr. Peter Milliken (Kingston and the Islands) moved for leave to introduce Bill C-210, an act to amend the Canadian Human Rights Act.

He said: Mr. Speaker, this bill to amend the Human Rights Act is one that was introduced during the last session of Parliament. I am reintroducing it.

In his 1989 report, the Human Rights Commissioner recommended certain changes in the act. In order to support the Human Rights Commissioner in his excellent work, I had drafted the proposals that he put forward in this bill.

Therefore, the bill could be proceeded with. Hon. members can consider the matter when it reaches committee. I would ask that we proceed with the bill at an early date.
