The Premier's Amendment. The Niagara Fower matter was reached at 3 a.m., when the Premier introduced an immedment to the statute law to give the Government Park Commissioners power to make any agreement they desired with any companies subject to the approval of the leutenant-Governor-in-Council. The amend-ment the Premier introduced was as fol-lows: The Commissioners of the Queen Vic-toria Niagara Falls Park, with the ap-proval of the Lieutenant-Governor-in-Council and the Canadian Niagara Pow-er Company may enter into an agree-




