

## STARTING TRIAL OF "BIG BILL" IN ARNSTEIN CASE

"Nicky" Arnstein Ordered Released on Charge of Contempt of U. S. Court.

REFUSED TO ANSWER ALL COURT QUESTIONS

Charge Against "Big Bill" Furey Is That He Received Stolen Property.

Washington, Nov. 8.—Following the Federal District Court, the Supreme Court today ordered the release of James W. (Nicky) Arnstein, who has been imprisoned in New York since August 14, on charges of contempt following his refusal to answer questions put to him in a bankruptcy hearing. Arnstein's name was connected with operations of an alleged "ring" of bond thieves in New York.

Try "Big Bill"

New York, Nov. 8.—A jury was selected today in general sessions to try Edward H. (Big Bill) Furey, who is charged with grand larceny and with criminally receiving stolen property in connection with the theft of bonds in New York's financial district. It was shortly after the arrest of Furey and Joseph and Irving Gluck, that James W. (Nicky) Arnstein was indicted for alleged complicity in the bond theft conspiracy.

One Trial Postponed

The trial of W. W. Basterday, also indicted for alleged bond thefts, was set over until after Easterday's trial.

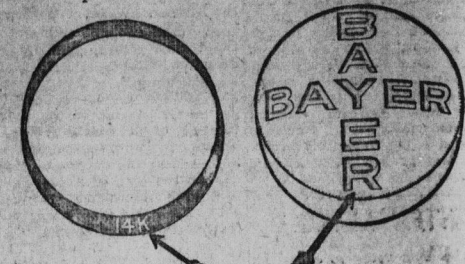

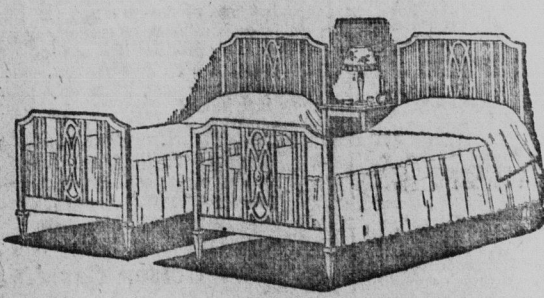
