

NINTH.—If any Member shall propose any Bill to this House, such Member shall produce the heads thereof in writing, having previously given at least twenty-four hours notice to the House.

TENTH.—Upon any material question or business being agitated in the House, and it is deemed necessary that a Committee of the whole House shall be formed, and the same being made by motion, and agreed to by a majority, the Speaker shall leave the Chair, and a Chairman shall be chosen, who is to report the proceedings of such Grand Committee in the body of the House.

ELEVENTH.—That all Bills presented from the Upper House, as well as those originating in this House, may be read twice in one day, and referred for a third reading to a future day, except such Bills as may require a more particular attention from the House, to be reserved for one reading only, on successive days.

TWELFTH.—That all Petitions to this House complaining of undue Elections and Returns, be presented on or before the fourth day of the Session.

THIRTEENTH.—That when a division at any time takes place, at the request of a single Member, the names of the Members dividing shall be inserted in the Journal.

FOURTEENTH.—That the papers and accounts presented to this House be carefully preserved by the Clerk, in whose custody they are intrusted; and that no person be permitted, without leave of the House, to take the same from the House, under any pretence whatever; and if any person shall presume to take any accounts or papers from the House, that the said Clerk do forthwith acquaint Mr. Speaker; that the House may be informed thereof.

A motion being made that a Committee be appointed to prepare an humble Address to His Excellency the Lieut. Governor, in answer to his Speech at the opening of the Session:

Ordered, that *Mr. W. McNeill, Mr. Brecken, Mr. Binns, Mr. Green, and Mr. D. McDonald*, be a Committee for that purpose.

Ordered, that a copy of the Journal be sent to His Excellency the Lieut. Governor

each day as soon as possible after the adjournment.

Ordered, that a Copy of the Journal be also furnished each day to *Mr. James Douglas Haszard*, Printer, and that he be directed to print one hundred and ten copies thereof—the same to be disposed of in the following manner:

- 3 Copies to each Member;
 - 2 Copies to each of the Members of the Legislative Council;
 - 6 Copies to the Lieutenant Governor;
 - 6 Copies for the Library;
 - 1 Copy each to the Governor, Legislative Council and Assembly of the Provinces of Upper Canada, Lower Canada, Nova Scotia, New Brunswick, and Jamaica;
 - 3 Copies to the Colonial Department;
 - 1 Copy to the Colony Agent;
- and the remainder to such Members of the British Parliament, or other persons, as the Speaker may direct.

Ordered, that at the end of the Session, the Clerk do see that the Journal of the Session is properly made out and fairly transcribed from the Minute Book, the printed Votes, and the original papers that have been laid before the House.

Ordered, that *Mr. Compton, Mr. Green* and *Mr. Pope* be a Committee for revising the Journal of each day after the adjournment.

Ordered, that *Mr. Owen, Mr. Brecken* and *Mr. H. Macdonald* be a Committee to examine what Laws have lately expired, or are near expiring, and to report thereon to the House.

A Petition of *John Willock*, of Queen's County, Esq. whose name is thereunto subscribed, complaining of an undue Election and Return for Queen's County, was presented to the House by *Mr. Brecken*, and the same was received and read.

Ordered, that the House do on Tuesday next, resolve itself into a Committee of Privileges and Elections, for the purpose of taking the aforesaid Petition into consideration.

Ordered, on motion of *Mr. Brecken*, that the said Petitioner be heard by Counsel at the Bar of the House.

Mr. Owen gave notice that he would, at an early day, move for leave to bring in a Bill to enable the Inhabitants of Georgetown to assess the holders of Town and Pasture Lots in that Town and Royalty, for the purpose of opening Streets, sinking Wells, and effecting other improvements.

Adjourned to 10 o'clock to-morrow.
