1. Whether J. T. Voisine lodged a complaint against Antoine Landry, postmaster of Notre Dame du Lac, county of Temiscouata, Quebec.

2. Whether said J. T. Voisine bore witness in an inquiry held in connection with political partisanship in which said Antoine Landry was the person charged.

3. If so, whether it was on the evidence of said J. T. Voisine that the commissioner based his report against said Antoine Landry.

4. Whether said J. T. Voisine was appointed acting postmaster to replace said Antoine Landry.

Also,—Return to an Order of the House of the 16th May, 1932, for a Return showing:—

1. Whether Alexandre Lebel lodged complaint against Andre Beaulieu, postmaster of Raudot, county of Temiscouata, Quebec.

2. Whether said Alexandre Lebel was a witness in the inquiry in connection with political partisanship brought against said Andre Beaulieu.

3. Whether said Alexandre Lebel was appointed postmaster to replace said Andre Beaulieu.

4. Whether the Postmaster General received a petition signed by a number of persons to the effect that only one man, Alexandre Lebel, wanted to change the site of the post office.

Also,—Return to an Order of the House of the 16th May, 1932, for a Return showing:—

1. Whether Mrs. Emile Ouellet, widow, lodged a complaint against Omer Sirois, then postmaster of Riou, county of Temiscouata, Quebec.

2. Whether said Mrs. Emile Ouellet was appointed postmistress to replace said Omer Sirois.

3. Whether she was appointed after a regular inquiry.
