payable. Teachers employed by the department are considered under contract; therefore no revision of pay and allowance is made during any contract period. However, in this case the present contract period expires in August 1960, and commencing with the new contract period in September, 1960 the teacher at Pikangikum will be eligible for both the isolation allowance and living allowance.

SKILLED LABOUR-ADVERTISING IN U.K.

Question No. 143-Mr. Winch:

1. Has the Department of Citizenship and Immigration done any advertising in the British isles in the past six months inviting immigrants to Canada and outlining employment opportunities in the construction industry, in such trades as car-

penters, plumbers, electricians and painters?
2. If so, has the department had any consultation with the national employment service or the unemployment insurance commission as to the availability of persons trained in these trades now resident in Canada?

Hon. Ellen L. Fairclough (Minister of Citizenship and Immigration): The answer to the first part of this question is yes and the answer to the second part is yes.

COAL SUBVENTION PAYMENTS, NOVA SCOTIA AND NEW BRUNSWICK

Question No. 145-Mr. Batten:

What was the total expenditure for transportation subventions on coal in (i) Nova Scotia; (ii) New Brunswick, for the periods (a) April 1, 1935, to March 31, 1957; (b) from April 1, 1957, to March 31, 1960?

Hon. Paul Comtois (Minister of Mines and Technical Surveys): Mr. Speaker, there could be a problem in the wording of this question. Coal subventions are not, generally speaking, paid in a specific province, although they are paid on behalf of coal from that province. This has been drawn to the attention of the hon. member for Humber-St. George's, and I am assured that the figures he wants are the total amounts paid on behalf of Nova Scotia coal and New Brunswick coal during the periods indicated. He has kindly offered to withdraw the question and reword it, but I do not think this is necessary.

With this clarification, the answer to (i) (a) is that subvention expenditures on Nova Scotia coal from April 1, 1935 to March 31, 1957 totalled \$66,437,765.54.

The answer to (i) (b) is that subvention expenditures on Nova Scotia coal from April 1, 1957 to March 31, 1960 totalled \$28,302,-797.86.

The answer to (ii) (a) is that subvention expenditures on New Brunswick coal from April 1, 1935 to March 31, 1957 totalled \$491,434.92.
