### **BOOKS CANADA LIMITED**

## Question No. 1,183-Mr. Andre:

1. What is the Crown's precise financial interest in Books Canada Limited as administered by the Department of the Secretary of State through the Association for the Export of Canadian Books and on what date was such interest acquired, at what cost and for what reason?

2. What was the book value of the Crown's equity on the date of acquisition and what is its latest estimated book value?

3. To date, what is the Crown's total investment, including equity costs, contributions to operating funds, debt forgiveness and what is the Crown's total realized profit from such investment?

4. In what manner is the Crown's interest represented (a) on the Board of Directors (b) in its senior management?

5. Did the government make a policy decision in regard to the future disposition of its interest?

Hon. John Roberts (Secretary of State): 1. The Crown does not have any financial interest (i.e. shares) in Books Canada Limited. It has been making contributions to the Association for the Export of Canadian Books/l'Association pour l'exportation du livre canadien, a non-governmental organization, since 1972. The AECB/AELC has recently acquired shares of Books Canada Limited. Prior to that acquisition, Books Canada Limited was wholly owned by a number of Canadian book publishers. The Crown has never owned any shares of Books Canada Limited (BCL).

2. The Crown has no equity in Books Canada Limited. See 1 above.

3. The Crown has never made a direct gift or contribution to Books Canada Limited. Because the Crown has no investment, it has made no profit. See 1 above.

4. The Crown has no financial interest in Books Canada Limited nor is the Crown represented on the board of directors or in its senior management.

5. Not applicable. See 1 above.

#### GRAIN TERMINAL, WINDSOR, ONTARIO

Question No. 1,242-Mr. Towers:

Did the government make grants to the grain terminal at Windsor and, if so, in what amounts and on what dates?

Hon. E. F. Whelan (Minister of Agriculture): The government has not made any grant to the grain terminal at Windsor. Specifically, the government has entered into a contractual agreement with United Cooperatives of Ontario, to make a repayable contribution towards the costs of constructing a grain terminal complex at Windsor, Ontario. Under the terms of the agreement, amounts of \$500,000 and \$8,000,000 were deposited into a trust account on April 29, 1977 and May 27, 1977 respectively, to be disbursed to U.C.O. upon certified presentation of documentation as to costs incurred during the design and construction phase. A repayment schedule has been prepared whereby U.C.O. will repay the contribution over a period of 15 years. In addition, all interest accruing on the

trust account and any amounts in the trust account remaining after completion of the project, will be returned to the Consolidated Revenue Fund.
