It seems to me there are many drawbacks and that very few benefits would ensue as a result of this measure. No one is against virtue, nor will anyone criticize a measure to prohibit gambling because it upholds virtue.

However, this measure is faulty because it does not achieve what it was intended to achieve. In fact, it is a threat to a program that is eminently desirable—allowing the provinces to collect certain sums of money that are then put to appropriate use to meet local needs, as I said earlier.

All things considered, Madam Speaker, Bill C-255 should be rejected, while all the requisite programs for gambling addicts should be made available to those who want to stop gambling.

Madam Speaker, psychology teaches us about the risk concept, which covers a very broad area and has yet to be resolved. However, psychology also teaches us that individual needs must be met in some way or other, and advertising is not a factor that will affect the individual's impulse to gamble. These problems can only be dealt with through support programs and programs that promote individual responsibility.

As is always the case with legislators who are asked to approve measures designed for the good of the public, we are confronted with options that are well-intentioned but also have a negative aspect.

In the case of Bill C-255, we feel the negative aspects loom much larger than the positive impact intended by this bill. That is why the bill will not accomplish its purpose. It will not achieve its objective and, Madam Speaker, in that case, the bill should not be passed.
