The reply was that the Government could not afford to bridge the river. The committee then suggested that the Government guarantee the bonds and thus enable a company to bridge the river. This proposition met with favor and the government promised to furnish plans, specifications and estimates which are now before the meeting. E M. Shaw corroborated his statement.

C. L. Smith was called upon and said he had promised to use his influence to get a bridge. The plans, specifications and estimates are here. The Government will guarantee \$20,000 worth of bonds. The bridge is yours if you will take hold and torm a company.
