70 CENT EGGS BOOM POULTRY COURSE

With Every Hen Laying Golden Eggs Soldiers Would Take up Poultry Business.

With eggs selling generally for seventy cents a dozen and a few house-holders coveting poultry because they are paying only fifty, the poultry course is the most profitable of the vocational training branch of the Military Hospitals Commission has much to recommend it even to the city man who never before considered the advisability of raising his own eggs.

To the returned soldier who finds himself untrained for strenuous work, or bound to some occupation because of an amputated leg or arm, the poultry course is an open door to independence. The initial outlay is not large and a competent man well trained can see a great future before him.
