

SUMMARY OF EVIDENCE IN THE CASE of B-63361 Tpr. Edward Michal
HYLAND, 8 Cdn Recce Regt (14CH) a soldier of the Canadian Army
(Overseas.)

The accused is informed of his rights.

The accused does not demand and the C.O. does not direct the evidence
be taken on oath.

FIRST WITNESS FOR THE PROSECUTION: Major C.R.H. Porteous, 8 Cdn Recce
Regt (14CH) states:--

"I am OC A. Sqn. to which Tpr. Hyland, whom I here recognize
belongs as does vehicle W.D. No. CZ 4204471. On the 25 Dec 43 this
vehicle was Sqn Duty truck from 1800 hrs 24 Dec 43 to 1800 hrs 25th.
Tpr. Morris the regular driver was relieved by Tpr. Horrocks at 0600
hrs and was to continue his tour of duty until 1800 hrs 25th. Tpr.
Hyland was never driving that day assigned to vehicle CZ 4204471 -
nor did he have permission to ride as a passenger in that vehicle.

Capt. McKnight the Orderly Officer and I are the only persons who
can authorize a trip beyond the Regimental Area. On the 25th I did
not authorize such a trip and produce the work ticket of that vehicle
in proof thereof. (Att Exhibit "A").

The accused declines to cross-examine.

SECOND WITNESS FOR THE PROSECUTION: Capt. G. McKnight, 8 Cdn Recce Regt
(14CH) states:--

I am Sqn 2 i/c of A. Sqn. On the 24-25 Dec 1943, I did not
give Tpr. Hyland whom I here recognize permission to take out
vehicle CZ 4204471. Nor to ride as passenger in it.

The accused declines to cross-examine.

CZ 4204471, nor did I give him permission to ride in it as a passenger.

The accused declines to cross-examine.
